

Volunteer Agreement

Eligibility

Billy's Way Home is a family friendly organization. We highly encourage people of all ages to volunteer with us. If you are a minor, we require consent from a parent or guardian.

Media Release

I hereby consent to being the subject of photographs taken by Billy's Way Home and authorize Billy's Way Home to cause the photographs to be exhibited with or without advertising sponsorships as still photographs, transparencies, motion pictures, television, social media or video. By this document I release Billy's Way Home, their agents, employees or assigns, from any and all claims for damages, libel, slander, invasion of privacy or any other claim based upon the use of my likeness.

Volunteer Agreement and Waiver Release

This agreement is between the reader ("Volunteer") and Billy's Way Home ("BWH"). Volunteer hereby offers his/her services to BWH to include, but not limited to, volunteering with BWH's outreach to homeless and poor people through the delivery of food (which may or may not use BWH vehicles), providing housing, performing construction or maintenance on BWH property, buildings, and fixtures, as well as volunteering in any other BWH program or project it offers from time to time (collectively the "Volunteer Services"). As a condition of my being accepted as a BWH volunteer and allowed to perform the Volunteer Services, I hereby agree to the following:

I acknowledge and agree that the nature of the volunteer services which are typically performed by an BWH volunteer, may involve (a) physical activity (including without limitation work with heavy tools and materials), (b) contact with unidentified, unfamiliar, and unpredictable persons (c) travel to and from various unspecified locations, (d) potential exposure to persons with infectious diseases, and (e) other potential risk of injury. I willingly and freely agree to volunteer and hereby assume any and all hazards or risk associated with the Volunteer Services, including without limitation risk of accident, personal injury, or death to my person or property which I may sustain in connection with my participation as a BWH volunteer in any BWH related project or activity. I am aware that I must follow any safety and hygiene protocols that have been implemented by BWH. I attest that I am not experiencing any symptoms of illness such as fever, cough, or shortness of breath. If I develop these symptoms I agree that I will cancel my shift before arriving at Outreach.

The undersigned hereby releases and covenants not to sue BWH and its directors, officers, partners, agents, employees, successors, assigns, licensees, sponsors, donors, representatives, volunteers, guests and affiliates from all liability, claims, suits, damages or cause(s) of action, whether known or unknown, arising out of or based upon or relating to my participation as an BWH volunteer in the Volunteer Services or any other BWH related activity or project for any and all property damage, personal injury or

death sustained by me or my minor child. I will indemnify and hold harmless BWH from any loss, liability, damage, cost or expense that they may incur as the result of any property damage or injury or death me or my child may sustain while acting as a BWH volunteer. I hereby acknowledge that BWH is an organization involved in serving the disabled chronically homeless. I hereby confirm, represent and warrant that I have never been convicted of a violent crime.

I hereby consent to being the subject of photographs taken by BWH and authorize BWH to cause the photographs to be exhibited with or without advertising sponsorships as still photographs, transparencies, motion pictures, television, social media or video. By this document I release BWH, their agents, employees or assigns, from any and all claims for damages, libel, slander, invasion of privacy or any other claim based upon the use of my likeness. I further irrevocably grant to BWH, its assigns and successors, my consent and full right to: photograph, film, audio, or video record my child during the course of volunteering with BWH, to use such photographs, films, name, image, voice, likeness, biography audio, or video recordings on the BWH website and other BWH print, media publications or guides, publicity or promotions.

I request and authorize BWH to provide, in their judgment, any immediate medical or emergency care my child may need due to injury or sickness. BWH can share information concerning the medical condition /treatment of my child to medical personnel or others BWH in its discretions determines is necessary to treat my child.
